No daily rental charges for up to 12 months*

As a Kirby Gas2Go® Club member you have access to a fleet of Gas2Go® refrigerant cylinders up to a maximum quantity that you nominate.

You can return empty cylinders and exchange them for full cylinders of any size (large, medium, small) and pay only for the refrigerant.

They are available for you to transact as many times as you need throughout the membership period, without incurring rental charges on these nominated fleet cylinders.

Cylinders which are part of the Kirby Gas2Go® Club can be kept for 24 months before they are deemed lost instead of the standard 12 months.

Reduce stock holdings by returning part-used cylinders for exclusive Gas Credits*

Kirby Gas2Go® Club members also have access to Gas2Go® Gas Credits. #Gas Credit refers to the value that you are credited for un-used refrigerant gas returned to Kirby.

You no longer have to hold on to un-used refrigerant gas and part-filled refrigerant cylinders – simply return these cylinders to a Kirby branch for a Gas Credit where applicable#.

Rate Charge Schedule

The new Kirby Gas2Go® Club service fees and charges are effective 1 September 2021 and are in addition to the Cylinder and Stillage Service Rate Charge Schedule under the standard Kirby Terms and Conditions of Sale and Hire and Credit Application.

Kirby Gas2Go® Club eligible Gas2Go® cylinders include the following refrigerants:

Select Freon refrigerant sold by Kirby - in either small (9-12kg), medium (16-22kg), and large (50-65kg) size. All natural refrigerants and industrial gases are excluded.

Membership Fees

Membership fees are based on the maximum number of cylinders that you have nominated in your fleet and can be a combination of eligible cylinders in small, medium or large size.

The fleet size is the maximum number of cylinders you can have in your possession at any given time without incurring rental.

The Kirby Gas2Go® Club Membership Fees are outlined in **Table 1** below.

Additional Gas Testing and Services

Gas2Go® Gas Doctor Testing Service – Provides laboratory analysis of the contaminant levels in used refrigerant (CO₂, HFC, HCFC & HFO gases) to ensure your refrigeration equipment is operating at optimum capacity. This service offers testing on CO₂, HFC, HCFC & HFO gases. Laboratory testing can identify any unknown gas component against the NIST data library. All product is tested in house at the Gas2Go® laboratory facility certified to ISO 9001 quality system.

Gas2Find™ – A leak detection gas used to identify refrigerant losses, when used in conjunction with a leak detector.



Additional Cylinder Rental

Additional cylinders that you require above your nominated maximum number of cylinders are automatically subjected to rental charges after the standard rent free period as outlined in the Cylinder and Stillage Service Rate Charge Schedule under the standard Kirby Terms and Conditions of Sale and Hire and Credit Application.

Gas Credit Service Fee

There is no Gas Credit Service fee on Top-Up cylinders for Gas2Go® Club members, however maximum kg limits apply. See **Table 2** below for details.

Gas Credit Calculation

A gas credit is calculated for the net gas weight rounded down to the nearest 1.0kg up to a maximum total per cylinder size. Maximum gas weights apply for eligibility for credit and the gas credit amount (kg) is determined using **Table 2** below.

Cylinder Size	Cylinder Capacity	Maximum kg Processed
Small	9-12kg	8kg
Medium	18-22kg	15kg
Large	50-65kg	30kg

Examples of gas credit calculation

Example 1:

Customer returns a small cylinder of 10kg, with 9kg of refrigerant. The maximum kg processed for a small cylinder is 8kg, therefore the gas credit will be calculated on 8kg.

Example 2:

Customer returns a medium cylinder of 22kg, with 14.8kg of refrigerant. The kg processed is rounded down to the nearest full kg, therefore the gas credit will be calculated on 14kg.



TERMS & CONDITIONS

- 1. Interpretation
- 1.1. The following terms shall have the following meanings unless the context shall require otherwise: –

"Conditions" means these Gas2Go® Club terms and conditions, the Kirby terms of sale and hire, the general warranty conditions of Kirby, any other conditions provided on Kirby's website and any agreed written variations. If there is any conflict, then in the absence of an express written variation from Kirby, the warranty provided on the Kirby website from time to time shall apply.

"Fleet" the maximum number of cylinders as nominated by you in your Gas2Go® Membership application.

"Gas2Go® Club Service Rate Charge Schedule" means the schedule of fees for the Gas2Go® Club which is available upon request from any Kirby branch or by contacting Kirby on Phone 13 23 50.

"Gas2Go® Club" means membership-based club which entitles Gas2Go® Members to participate in Kirby's Gas2Go® gas management system under through which Kirby provides the Gas2Go® Goods to Gas2Go® Members.

"Gas2Go® Goods" means the goods provided to Gas2Go® Members. "Gas2Go® Members" means a Buyer who is accepted by Kirby as a current member of the Gas2Go® Club pursuant to Kirby's Gas2Go® Club Conditions.

"Gas2Go® Club Membership Conditions" means the terms and conditions of membership of the Gas2Go® Club.

"Kirby" means Kirby HVAC&R Pty Ltd (ABN 42 624 910 041) and its successors and assigns.

- 2. Kirby Terms and Conditions
- 2.1. These conditions incorporate Kirby's standard terms of sale and hire and to the extent of any inconsistency, these Conditions will prevail.
- 3. Membership
- 3.1. The membership fee is a one-off annual payment calculated based upon the nominated cylinder Fleet size as outlined in the Gas2Go® Club Service Rate Charge Schedule and will be charged to your account at the end of the twelve-month term. Charges and rates are for new memberships as of the 1st of September 2021.
- 3.2. At expiry of the membership period, you can retain the cylinder/s by renewing the membership.
- 3.3. Unless you advise Kirby of your intention to cancel the membership in writing, before the renewal date, the renewal will take place automatically on the anniversary date of when the membership first started. Whereas the fees are chargeable at the end of the term. The membership is payable in line with agreed Kirby terms of sale and hire.
- 3.4. If you do not wish to renew your membership, outstanding cylinders in your possession will be charged daily rental from the date of expiry of membership and cylinder rental conditions apply.
- Membership fees are non-refundable for cancellation of membership.
- 3.6. Membership fees are reviewed annually and may be subject to change.
- 3.7. Kirby reserves the right to reject your application for Gas2Go® Membership or cancel your Gas2Go® Membership.

4. Cylinders

- 4.1. The maximum number of cylinders that you have nominated is your Fleet and can be a combination of Kirby Gas2Go® cylinders in sizes of small (9-12kg), medium (16-22kg), and large (50-65kg) refrigerant (Freon) cylinders. The Fleet size is the maximum number of cylinders you can have in your possession at any one time without incurring rental. A full list of Kirby Gas2Go® cylinders is available in the Service Rate Charge Schedule.
- 4.2. Additional cylinders that you require above your nominated maximum number of cylinders are automatically subjected to rental charges after the standard rent free period. If additional cylinders are returned rented cylinders will automatically convert into the Gas2Go® Club Fleet.
- 4.3. The 'maximum' number of cylinders can only be reduced at the time of membership renewal.
- 4.4. The customer must declare any lost cylinders, or else they will still be considered as part of the customer's nominated maximum which would limit the number of cylinder exchanges available to the customer. Lost cylinders are subject to the standard Kirby lost cylinder charge:
 - a. does not include industrial cylinders including Ammonia,
 Nitrogen, Carbon Dioxide, Acetylene and Oxygen or drums over
 65kg or specialty refrigerants in non-Kirby cylinders.
 b. does not include Stillages.
 - c. does not include Pumpdown & Reclaim Cylinders.
- 4.5. Cylinders will be deemed lost, and customers will be charged a 'lost' cylinder fee for cylinders outstanding for more than 24 months as outlined in the Kirby standard terms and conditions of sale.
- 5. Gas Credit, Fees and Charges
- 5.1. The cylinders, fittings, and caps supplied by Kirby to you as part of the Gas2Go® Club, remain the property of Kirby Australia Pty Ltd and are to be returned to Kirby in the same condition as when received, ordinary wear and tear accepted as outlined in the Kirby standard Terms and conditions of sale.
- 5.2. Gas Credit is applicable on certain refrigerants in a cylinder under the nominated club.

Fleet:

a. Is given for the net gas weight rounded down to the nearest 1.0kg. Gas Credit amount (kg) is determined using the table provided in the service charge schedule.

b. Cylinders must be serviceable and not damaged in any way and the Refill Protection Device (RPD) must be intact.
c. No credits will be provided for damaged cylinders and charges may apply for damaged cylinders.

d. The value will be based on the customer's current net price on the day of return or the original invoice price of the cylinder, whichever is the lesser amount will be applied to your Kirby account and is subject to normal trading terms. Any Gas Credits will be offset against the account balance and any rebates due are not available on superseded or discontinued products.

e. Service is subject to change to account for prevailing market conditions

6. Privacy

6.1. Kirby will collect and deal with personal information in relation to the members in accordance with the Privacy Act 1988 (Cth) as amended from time to time and the Kirby privacy policy which is available on the Kirby website.
