ELIGIBILITY

The **Kirby Apprentice Fund CO2 Training Scholarship** opportunity is targeted at 4th year apprentices that are looking to extend on their existing knowledge of the trade and further themselves with an understanding of future/natural technologies.

To be eligible for the scholarship, you must meet the following requirements.

- You must be registered in the Kirby Apprentice Fund.
- You must be currently enrolled in an approved TAFE or approved RTO refrigeration-based trade course.

SCHOLARSHIP DETAILS

- The Kirby Apprentice Fund CO2 Training Scholarship offer is strictly limited to 15 placements only in April 2025.
- The scholarship consists of a three (3) day, CO2 Safety and Systems Technology Training experience, conducted at the award-winning Beijer Ref Academy, Bankstown Aerodrome NSW. The program consists of;
 - CO2 Safety and CO2 Repair and Service Systems Training conducted by SCM REF AU and Superior Training Centre Pty Ltd (RTO ID Number 41122)
 - Refrigeration Systems Controls Training, conducted by Copeland and Danfoss
 - New Refrigerants Training, conducted by Beijer Ref
 - Australian Refrigeration Council Green Scheme Accreditation (2 years).
- Two intakes in 2025 for two courses to be held in Sydney, Australia. First course conducted 8th, 9th, 10th April 2025
- Recipients must be available to undertake the CO2 training course at the nominated time.
- The CO2 Training Scholarship will be applied to the CO2 course fees, 3 days accommodation during the course program, meals and hotel transfers to and from the nominated training venues.
- The scholarship <u>does not</u> include travel to and from Sydney, flights for interstate recipients, or airport transfers to the hotel.
- The scholarship contribution is not transferable or redeemable for cash.

Any scholarship awarded is on the basis that the recipient attends and completes the 3-day program as outlined. Any failure to attend due to negligence may result in the course costs charged back to the Apprentice's nominated employer.

- 1. Applications for 2025 Kirby Apprentice Fund CO2 Training Scholarships are now open and close 5pm (AEST), 14 March 2025.
- 2. Complete the application form below and email it to Kirby HVACR Pty Ltd, via training@kirbyhvacr.com.au by the closing time and date. Attach all required supporting documents to your application.
- 3. If your application is received after the closing date, is incomplete or does not meet the requirements set out in the scholarship eligibility terms, it will not be considered.
- 4. By submitting your scholarship application form, you and your employer accept the scholarship terms and conditions and have taken to have read them.
- 5. Kirby HVACR will convene a panel to assess all valid applications. Applications will be assessed on merit, based on your responses in your application and the scholarship eligibility requirements.
